4. Approval of Previous Minutes

6. Committee Chair Reports

- Lawn Committee chairperson, Bob Kelley:
 - Informed the community that fertilizer will begin on Thursday, May 24th.
 - The tree trimming requests are being caught up throughout the community, and should be completed soon.
 - The Elm Court erosion and drainage project has been complete.
 - A check of the rain sensors throughout the community indicates that the sensors turned off automatically, as they should, so the mechanisms are working properly.

- Trees along the stone wall surrounding our community are being addressed. Remember, if the tree is in your yard, it's your responsibility to trim them.
- The painting project for the pool coping has also begun.
- Activity Committee chairperson, Carol Najarian, informed the community of an upcoming 4th of July party, and details will be coming soon.
- Lodge Committee (Lisa Kelley)reported a great turn out for the garage sale, and thanked all whom donated items to help the community. (\$1500)
- Facilities ()Ken Gendolfe):
 - Information on the exterior Lodge Lighting was provided. Three bids were reviewed; Carl Electric provided the most for the money; \$8102.50 requested for approval...Motion Carried.
 - Work on recovering the Pools Tables has begun, expected completion by end of next week (1 June)
- Security (Gary Ensminger): 13 Residents must get new entry stickers by June 1st.

The Board of Directors has reviewed a bid proposal from Carl Electric to replace the lights illuminating the Lodge Parking Lot and surrounding sidewalks/pathways with more efficient LED lighting. The savings we experience in electricity will pay for the expense of replacing the existing lighting over the next few years. The Board of Directors made a motion, seconded and unanimously approved the expense of \$8,102.51 to Carl Electric to make repairs/replacements.
